4. Approval of minutes of previous meeting held on 26th July 2021

The minutes of the last meeting held on 26th July were proposed for acceptance by Cllr Parry, seconded by Cllr Monks, and unanimously accepted as a true record of proceedings.

5. District Councillors' Report – Cllr Parry

Cllr Parry filed the following report:-

South Warwickshire Council Consultation – HAVE YOUR SAY

An extensive public consultation has started across both Stratford and Warwick District Council areas on proposals to create a South Warwickshire District Council. It concludes on 24th October and both individuals, parish councils and organisations are encouraged to take part – the survey takes less than five minutes to complete.

Both Stratford-on-Avon and Warwick District Councils face a very uncertain financial future, although for slightly different reasons. Government funding for all Councils has

reduced in recent years, and at Stratford-on-Avon yet further significant reductions are expected due to changes to the New Homes Bonus scheme this autumn, whereas at Warwick District the cost of delivering services, including refuse and recycling, is expected to increase significantly.

It is estimated that both Councils will have a shortfall of around £4-6m each year by 2025/26. Across the two Councils this means that £10m of annual savings are needed over the next five years to address this shortfall and help preserve services.

Faced with this financial pressure, and not wanting to see reductions in the current level of services, both Stratford-on-Avon and Warwick District Councils have been exploring a number of ways to work together to tackle this shortfall and reduce the impact on residents and service users.

Both Councils agreed the ambition to create a South Warwickshire Council earlier this year, and for this Council to be financially sustainable. **This consultation will help us understand whether you support this proposal.** Without the level of savings that could be expected through the creation of a South Warwickshire Council, there would be serious consequences on future service delivery.

The two Councils have similar sized budgets of approximately £17m. They serve similar sized populations, with a broadly similar net General Fund cost per head of population. They both serve a combination of towns and rural areas, with many challenges in common. There is a consistent geography already established for the South Warwickshire Community Safety Partnership, the Shakespeare's England Destination Management Organisation and the South Warwickshire Health Partnership. Residents of the South have consistent needs and concerns around areas such as rural transport, traffic and congestion and affordable housing.

During the last year both Councils have worked closely together on responding to the challenges from COVID. The pandemic has identified a lack of resilience in some service areas due to size of both authorities being relatively small. However, Stratford-on-Avon and Warwick have already started sharing services to address these resilience issues and from August this year the vast majority of Senior Management Team posts are shared.

The Councils believe that merely sharing some services does not make sufficient financial savings and still leaves considerable duplication. Stratford-on-Avon and Warwick District Councils are therefore considering a proposal to fully merge, in which case a new District Council would be established covering the whole of South Warwickshire, the areas currently covered by Stratford-on-Avon and Warwick District Councils.

South Warwickshire Local Plan

Stratford-on-Avon and Warwick District Councils have commenced the initial stages in the development of a Local Plan and have undertaken a Scoping and Call for Sites consultation, which closed in June and has generated the submission of over 500 sites which are currently being reviewed by the joint policy team. This is the first stage in a long process and the consultation asked a series of questions about what issues the new Local Plan should cover and sought views on how we should tackle these issues.

Business Grants

Throughout the pandemic local government has been responsible for the administration and payment of the various and numerous Central Government Grant Schemes. To date SDC has paid out over £70 million in grant funding and it is great news that the village hall has been able to benefit from these grants over the last 18 months.

SDC has worked closely with Coventry and Warwickshire LEP Growth Hub to ensure that payments of grants have reached those in most need. SDC has subsequently received a further indicative funding of £1.4 million from July which was only available to those local authorities who had spent their original allocation. This new tranche will consequently be used to support existing businesses to flourish post-pandemic.

Planning and Enforcement

The planning teams continue to be swamped by householder applications for extensions which reflects the increase of homeworking during Covid and the new hybrid model of working that is being adopted by many businesses to look at greater flexibility of working routines amongst staff combining a mix of office based with home working routines. Whilst applications have recently been taking 5 weeks to be validated this has now reduced to around 2 – 3 weeks despite the volume and staff shortages within the planning team.

Local Enforcement

The Council has recently reviewed its existing Local Enforcement Plan with a view to better targeting the investigation resources at the most serious issues. SDC is working hard to negotiate a revised contract for recycling waste across the district following the fire at Pure in July for the next 18-24 months until the new facility at Coventry is built and up and running. The cost implications of this interim service however are significant.

6. County Councillors' Report – Cllr O'Donnell

Cllr O'Donnell filed the following report:-

Covid19

The rate of infections across the district has decreased sharply to 263/100,000 from 308 last week, the over 60's rate has increased to 115/100,000 (105 last week) with 49 cases over the last seven days. Other districts rates in Warwickshire, for all ages, are Nuneaton & Bedworth 444/100,000, North Warwickshire 371/100,000, Warwick 323/100,000 and Rugby 420/100,000. Warwickshire overall has gone from 340/100,000 to 360/100,000. England 300/100,000.

There have been two further Covid related deaths across Stratford District (total now 417 from the start of this second wave (28th August 2020) 37 occurring in care homes, 97 in hospital, two in a hospice and 10 at home and one in a communal establishment, out of a total of 1,439 all cause deaths in the district for this new second wave period. The cumulative total of deaths across Warwickshire for Wave 2 increased by 6 this week (708) with a total of 6,001 all cause deaths. The cumulative total of Covid-19 deaths in Stratford district is 315 since the start of the pandemic and in Warwickshire 1,309 (10,385 total deaths).

7. Warwickshire College Report

The following report was submitted.

Farm

The combined harvesting was completed in the 2nd week in August and produced a good yield. This year the cropping will be all winter wheat. We're increasing our wild bird and wildflower areas this year, and also over seeding some of the grassland with herbs and legumes. This is in line with the government's vision for farming and a push towards reducing inorganic inputs.

The cattle and sheep are all well and now the students have returned, they will be back onto the farm to help sort the ewes into their lambing groups.

Estates

The electrical rewire of Cotswold Court has been successfully completed during the summer and staff and students are now back in occupation. Several pathways around the residential accommodation areas have been resurfaced and we will shortly commence refurbishing areas of the tiered car park on Lime Tree Drive. The upgrade of bathroom showers in Feldon student residential block was also completed over the Summer break.

We have been approached by Wellesbourne and Walton Flood Action Group with a request to work with them to alleviate flooding and flood risk to Wellesbourne and Walton. They are approaching all landowners in the area. In the first instance, this means sharing our details of our land ownership with them, secondly this means them visiting our site to understand where the water courses run leading to the river and stream that floods in their area. Based on this visit and information they would be likely to put forward suggestions for solutions at Moreton Morrell that would slow the water flow down, thus managing flood waters and hopefully alleviate flood damage. These solutions could include 'leaky dams' and installation of 'fallen trees' to slow down the flow and such like. They are able to obtain grant funding for these interventions, so there would be no cost to the college, they

would also be able to engage with experts to understand the impact of these interventions on the College.

Staff and Students

We are pleased to say the number of Agriculture students has increased significantly at Moreton Morrell; hopefully showing a new interest in the industry from young people in the great career opportunities it has to offer.

Recently discovered TV star Kaleb Cooper of 'Clarkson's Farm' fame, was a Moreton Morrell College Agriculture apprentice once, and when he dropped in to chat to staff at the Moreton-in-Marsh Show on 4th September, he agreed to come back to college to meet the next generation of agriculture students.

Cllr Edwards reported the Party in the Park had been a success with over 130 attending, and the weather was good. A vote of thanks was given to Cllr Edwards, Cllr Slora and Gill Slora, and others involved in organizing.

As the bands didn't want direct payment it was resolved to make a donation of £200 to charity, to be agreed later.

The Clerk reported on the latest playing field report, there were 68 issues, all fairly minor. 15 are no action and monitor, things like strimmer damage, 5 are cut back vegetation, 6 are kompan warranty/ adjustments, 6 are add soil and reseed, 11 are sand , remove rust , treat or paint – the big item is the multiplay play hut, 10 are adjust / tighten / repair – no parts and 15 require parts like swing seats etc.

No handyman had come forward as a result of the previous adverts. However, Mr Routly offered his services at £20/hour to manage the procurement of parts and conduct all the

repairs, he estimated 50 hours in total, and £950 for parts. A total budget of £1000 for labour and £1000 for parts was proposed by Cllr Edwards, seconded by Cllr Keavy and carried unanimously.

The Clerk reported she was successful in the PC being award a WCC grant of £511 towards a youth shelter, and thought MMCT may also may a donation. It was resolved to obtain quotations. *Clerk to follow up*

The Clerk reported she had contacted all local councils via WALC about CCTV, and discovered it's a minefield. Basically the councils that have them are urban, Coleshill, Alcester, Wellesbourne, Shipston, Cheswick Green (Solihull), no rural councils replied saying they had CCTV. SDC stated as its a public area and we are a public body we have to comply with all the regulations, and there are many including 12 principles the require compliance. Costs would be approx £1000 per camera per year for SDC or approved body to monitor plus installation (Approx £5,000 per camera), police also require access. As a result the Clerk recommended not to proceed, especially we do not seem to have had any issues this summer. It was agreed not to progress but continue to monitor.

Cllr Edwards introduced Keith Greetham to speak about the new Hasting House Charity.

Mr Greetham addressed the meeting, explained the purpose of the charity and the fact it was trying to cover a gap in services . Charitable status had been achieved and Hasting House medical centre had 12,500 patients. There were 4 initial issues they wanted to address . Role of navigator, help for people with social exclusion before medical intervention, young persons mental health , and a toe nail cutting service. Funding in excess of £50k per year would be required to cover these items and they were looking to fund raise . In future the PC may be asked a donation.

It was resolved to consider the above in the budget.
